**Sound and Lighting:** Sound and lighting equipment shall be provided by Presenter. Please go to [www.thegimbles.com](http://www.thegimbles.com) to download the most recent tech sheet.

**Recording:** No commercial recording (audio or video) will be made of the performance without the written permission of **The Gimbles**. Archival recording is permitted, with prior arrangement.

**Insurance:** Presenter warrants that it has both personal injury and property damage liability insurance on the premises at which the performance shall be given.

**Jurisdiction and choice of law:** This agreement shall be governed and construed in accordance with Texas State law. By signing this agreement, the parties recognize the full jurisdiction of Texas courts relative to any dispute arising out of this agreement.

**Force Majeure:** If either party is prevented from performing the obligations created because of illness, an Act of God (defined as fire, flood, accident, riot, order of authority or any other calamity) or if by reason of war, infectious disease outbreak, issues of national security, strikes, lockouts, or any other cause beyond the control of either party, neither party shall be liable for the balance of the contract.

**Additional Provisions**

Presenter will:
